CIS provided tutors, mentors, academic assistance, attendance monitoring, behavioral interventions, parent engagement opportunities, and social-emotional learning groups. During the fiscal year, more than 470 students received individualized support and over 3,800 benefited from school wide support, basic needs items, and enrichment activities.


